

### **BorgWarner fournira son module de propulsion intégré (iDM) à un grand constructeur chinois de véhicules hybrides**

- *Le module de propulsion intégré de BorgWarner répond aux besoins du système hybride*
- *La technologie démontre le leadership de BorgWarner dans le domaine des systèmes de propulsion électrique*
- *L'intégration des technologies est synonyme d'économies*

*Auburn Hills, Michigan, 2 août 2023* – BorgWarner a annoncé la livraison d'un nouveau module de propulsion intégré (iDM) à un grand constructeur chinois. La technologie BorgWarner améliore l'expérience globale de la conduite d'un véhicule hybride grâce à un meilleur rendement. La production est prévue au deuxième trimestre de 2024.

« L'iDM de BorgWarner affiche un niveau élevé d'intégration et donne des résultats remarquables, » a déclaré Stefan Demmerle, Président et General Manager de BorgWarner PowerDrive Systems. « Nous sommes ravis de ce tout récent contrat qui va renforcer notre partenariat avec ce grand constructeur chinois. Ensemble, nous avons l'intention de saisir de nouvelles opportunités dans le domaine des véhicules à énergie nouvelle et de participer en commun au développement de l'industrie automobile chinoise. »

L'iDM est composé de deux onduleurs, deux moteurs électriques et d'une transmission électrique, dans un format compact, permettant la réduction du coût. Point remarquable, les unités à double onduleur contrôlent dynamiquement les deux moteurs électriques en fonction des conditions de fonctionnement du véhicule afin d'obtenir une propulsion souple et efficace. Éléments clés du système hybride, les doubles onduleurs et les doubles moteurs électriques mettent en œuvre une variété de modes de fonctionnement pour aider le véhicule à gérer la propulsion et la récupération d'énergie augmentant ainsi le rendement.

La production de l'iDM devrait être confiée à l'usine BorgWarner chinoise de Wuhan.
