BorgWarner liefert weitere Leistungselektronik an europäischen Premium-OEM

- *Liefervertrag für kombinierten Inverter und DC/DC-Wandler (CIDD) erweitert*
- *CIDD bietet kompakte Lösung zur Versorgung elektrischer Antriebs- und Zubehörsysteme*
- *Einsatz in allradgetriebenen Hybridanwendungen des B- und C-Segments*

Auburn Hills, Michigan, 7. November 2023 – BorgWarner wird einem europäischen Premium-OEM weitere kombinierte Inverter- und DC/DC-Wandler-Einheiten (CIDD) für den Einsatz in dessen allradgetriebenen Hybridanwendungen des B- und C-Segments liefern. Durch die Kombination von Inverter- und Wandlerelementen kann der kompakte CIDD sowohl den Elektroantrieb eines Fahrzeugs als auch dessen Zusatzsysteme mit Strom versorgen. Damit erfüllt er die Ziele des OEM, die Leistungsdichte in einer Einheit zu maximieren, die gleichzeitig leichter, kleiner und kostengünstiger ist.



Das CIDD-Design von BorgWarner nutzt das Viper-Leistungsmodul mit doppelseitiger Kühlung und bietet eine doppelt so hohe Leistungsdichte wie sonstige Module auf dem Markt. Dazu kommt die Skalierbarkeit, um die unterschiedlichen Leistungsanforderungen verschiedener Anwendungen zu erfüllen. Kombiniert mit Stromversorgung und Gate-Treiber-Schaltungen der nächsten Generation ermöglicht die höhere Systemeffizienz eine verbesserte Fahrzeugreichweite. Durch die Integration des Steuerschaltkreises und der DC/DC-

Wandlerfunktionen auf einer Platine im CIDD sind keine Drahtverbindungen, separates DC/DC-Wandlergehäuse und flüssigkeitsgekühlten Anschlüsse erforderlich. Außerdem wird die teure Hochspannungsverkabelung zwischen den Gehäusen reduziert. Dies alles führt zu optimiertem Gewicht und erhöhter Zuverlässigkeit.
