# BorgWarner Participates in Human Rights Campaign Foundation's 2023-2024 Corporate Equality Index

- Index acts as benchmark to measure policies, practices and benefits relating to LBGTQ+ employees
- Included for third consecutive year

Auburn Hills, Michigan, December 6, 2023 – BorgWarner, a global product leader in delivering innovative and sustainable mobility solutions for the vehicle market, has been included again on the Human Rights Campaign Foundation's 2023-2024 Corporate Equality Index (CEI), the nation's foremost benchmarking survey and report measuring corporate policies and practices related to LGBTQ+ workplace equality. The company joins the ranks of 1,384 major U.S. businesses that were also ranked in the 2023-2024 CEI.

"BorgWarner is proud to be recognized once again as a company that prioritizes diversity and continuously strives to build an inclusive and supportive environment for all, including those who identify as LGBTQ+," said Tania Wingfield, Executive Vice President and Chief Human Resources Officer, BorgWarner. "Our company culture, driven by our Beliefs, will continue to become more progressive and accepting so that every employee can feel supported to be their entire, authentic self at work."

"For well over two decades, businesses have played an important role in furthering LGBTQ+ equality by centering employee needs and voices when it comes to workplace inclusion. While there is much more work to be done, year-over-year growth in CEI participation is evidence of a business community that recognizes the responsibility and value in upholding equity and inclusion," said RaShawn "Shawnie" Hawkins, Human Rights Campaign Sr Director of Workplace Equality. "Our goal at the Human Rights Campaign Foundation is to work in a spirit of partnership with companies, providing educational resources and leading benchmarking, and collaborating on ways for businesses to support the LGBTQ+ community at a time when we face unprecedented

legislative attacks, heightened anti-LGBTQ+ rhetoric and physical violence. The CEI is an everevolving tool – a blueprint that companies can use to show up more effectively in supporting their LGBTQ+ employees and their families."

The results of the 2023-2024 CEI showcase how U.S.-based companies are promoting LGBTQ+ friendly workplace policies in the U.S. and abroad. The first year of the CEI included 319 participants, and the 2023-2024 CEI now includes 1,384 participants; further demonstrating the tremendous trajectory of the CEI, a record-breaking 1,340 businesses have non-discrimination protections specific to gender identity, up from just 17 in 2002. These critical non-discrimination protections cover 21 million employees in the U.S. and around the globe.

The CEI rates employers providing these crucial protections to over 20 million U.S. workers and an additional 18 million outside of the U.S. Companies rated in the CEI include Fortune magazine's 500 largest publicly traded businesses, American Lawyer magazine's top 200 revenue-grossing law firms (AmLaw 200), and hundreds of publicly and privately held mid- to large-sized businesses.

The CEI rates companies on detailed criteria falling under four central pillars:

- Non-discrimination policies across business entities;
- Equitable benefits for LGBTQ+ workers and their families;
- Supporting an inclusive culture; and,
- Corporate social responsibility.
